## Kid Reporter Terms and Conditions

**ELIGIBILITY:** The LEGOLAND® New York Resort Kid Reporter Search is open to children between the ages of 6-12 who live within 100 miles of LEGOLAND® New York Resort, Goshen, NY (“Contestant”) and have parental consent to enter and participate in the Kid Reporter Search.

**HOW TO ENTER:** There is no purchase necessary to enter. Each contestant may submit only one entry to LEGOLAND® New York Resort (“Sponsor”); additional entries will not be considered. To let Sponsor know your minor child has permission to enter Kid Reporter Search, a parent/legal guardian of the Contestant must: (1) use their own email account to email the Contestant’s video submission to [llny.kidreporter@LEGOLAND.com](mailto:llny.kidreporter@LEGOLAND.com) or (2) use their registered Facebook account to publicly post the video submission to the LEGOLAND® New York Resort Facebook page with the #LLNYKidReporter hashtag included. Kid Reporters selected will be notified on platform used for submission (on parent’s Facebook account via direct message or through parent’s email account). Each potential winner must accept the Kid Reporter job and prizes within five (5) days of announcement by: (1) the parent/legal guardian replying to the notification from LEGOLAND® New York Resort with an acceptance message, (2) the parent/legal guardian returning signed and completed to LEGOLAND® New York Resort any required parental consent, proof of age, talent release consent to Kid Reporter being filmed and photographed with their likeness being used for public relations and marketing collateral, or permitting forms provided to them by Sponsor within timeframe set by Sponsor, and (3) the selected Kid Reporter committing to:
